

RETAINER AGREEMENT

ON THIS _____ DAY OF _____, 200__ GOLDRICK INVESTIGATIVE ASSOCIATES, INC. HEREINAFTER REFERRED TO AS THE AGENCY, AND _____, REFERRED TO AS THE CLIENT, HEREBY AGREE TO THE FOLLOWING TERMS AND CONDITIONS:

FIRST: The CLIENT, by signature to this agreement, hereby retains the AGENCY to conduct an investigation on behalf of the CLIENT; and,

SECOND: The CLIENT hereby agrees to pay the AGENCY, a fee of \$_____ per hour, per investigator, for Investigations (**four hour minimum per day**) plus all out of pocket expenses, database search fees, mileage (**.60 cents per mile**), film and developing, tolls, parking, and any other reasonable expenses incurred in the performance of such investigation. The taking of depositions, research, investigation review, travel, phone calls, report preparation, surveillance preparation, conferences or any court-related appearances is considered part of the investigation and payable as above. Cancellation of an investigation requires an 8-hour prior notice or a **\$500.00** dismissal fee will be applied; and,

THIRD: The CLIENT agrees to pay a retainer fee of \$_____ prior to the initiation of the investigation. If the investigation is terminated or completed prior to the expenditure of the total retainer amount, any such retainer balance shall be refunded to the CLIENT without interest; and, The retainer amount will not be exceeded by more than \$_____; and,

FOURTH: The CLIENT agrees to pay all amounts due at such time as CLIENT is billed by the AGENCY, and agrees to pay the final fee balance in full prior to the delivery of the investigative report to the CLIENT, and agrees to pay interest to the AGENCY at the rate of 2% (two percent) per month on the unpaid principal of any overdue balance; and,

FIFTH: The CLIENT agrees to hold harmless, the AGENCY, and/or it's employees or agents from any and all actions, causes of actions, claims, damages and demands of whatever type wherever situated arising directly or indirectly from the investigation; and,

SIXTH: In consideration of the foregoing terms and conditions, the CLIENT understands that the AGENCY shall under its best efforts, investigate at its sole discretion, via any lawful means it deems to be appropriate. It is agreed that the AGENCY has made no guarantee to the CLIENT as to the results regarding this investigation.

I HEREBY AUTHORIZE GOLDRICK INVESTIGATIVE ASSOCIATES, INC., TO CONDUCT AN INVESTIGATION ON MY BEHALF, AND AGREE TO THE TERMS AND CONDITIONS DESCRIBED ABOVE.
